प्रिंट और प्रतिबंध

ईस्ट इंडिया कंपनी के तहत 1798 से पहले का औपनिवेशिक शासन सेंसरशिप या पाबंदी लगाने के बारे में ज्यादा परेशान नहीं था। मजेदार बात तो यह है कि मुद्रित सामग्री को नियंत्रित करने के इसके शुरुआती कदम कंपनी के कुप्रशासन की आलोचना करने वाले और कंपनी के हुक्मरानों के काम को कोसने वाले अंग्रेजों के खिलाफ उठे। कंपनी को इस बात की चिंता थी कि इन आलोचनाओं का लाभ उठाकर इंग्लैंड में बैठे इनके निंदक कहीं भारत पर इनके व्यापारिक एकाधिकार पर हमला न बोल दें।

कलकत्ता सर्वोच्च न्यायालय ने 1820 के दशक तक प्रेस की आजादी को नियंत्रित करने वाले कुछ कानून पास किए और कंपनी ने ब्रितानी शासन का उत्सव मनाने वाले अखबारों के प्रकाशन को प्रोत्साहन देना चालू कर दिया। अंग्रेजी और देसी भाषाओं के अखबार-संपादकों द्वारा गुहार और अर्जी लगाने के बाद 1835 में गवर्नर जनरल बेंटिंक प्रेस कानून की पुनर्समीक्षा करने के लिए राजी हो गया। फिर उदारवादी औपनिवेशिक अफसर टॉमस मेकॉले ने पहले की आजादियों को बहाल करते हुए नए कानून बनाए।

Print and Censorship

Before 1798, the colonial state under the East India Company was not too concerned with censorship. Strangely, its early measures to control printed matter were directed against Englishmen in India who were critical of Company misrule and hated the actions of particular Company officers. The Company was worried that such criticisms might be used by its critics in England to attack its trade monopoly in India.

By the 1820s, the Calcutta Supreme Court passed certain regulations to control press freedom and the Company began encouraging publication of newspapers that would celebrate British rule. In 1835, faced with urgent petitions by editors of English and vernacular newspapers, Governor-General Bentinck agreed to revise press laws. Thomas Macaulay, a liberal colonial official, formulated new rules that restored the earlier freedoms.

जल आपूर्ति

स्वतंत्रता के बाद भारत में तेजी से औद्योगीकरण और शहरीकरण हुआ और विकास के अवसर प्राप्त हुए। आजकल हर जगह बहुराष्ट्रीय कंपनियाँ (MNCs) बड़े औद्योगिक घरानों के रूप में फैली हुई हैं। उद्योगों की बढ़ती हुई संख्या के कारण अलवणीय जल संसाधनों पर दबाव बढ़ रहा है। उद्योगों को अत्यधिक जल के अलावा उनको चलाने के लिए ऊर्जा की भी आवश्यकता होती है और इसकी काफी हद तक पूर्ति जल विद्युत से होती है। इसके अलावा शहरों की बढ़ती संख्या और जनसंख्या तथा शहरी जीवन शैली के कारण न केवल जल और ऊर्जा की आवश्यकता में बढ़ोतरी हुई है अपितु इनसे संबंधित समस्याएँ और भी गहरी हुई हैं। यदि आप शहरी आवास समितियों या कालोनियों पर नज़र डालें, तो आप पाएँगे कि उनके अंदर जल पूर्ति के लिए नलकूप स्थापित किए गए हैं। इसमें कोई आश्चर्य नहीं है कि शहरों में जल संसाधनों का अति-शोषण हो रहा है और इनकी कमी होती जा रही है।

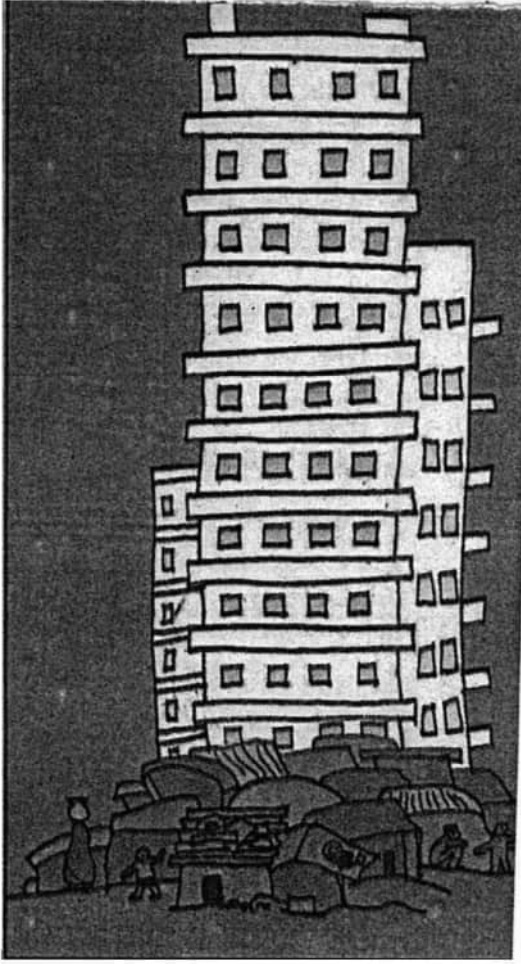

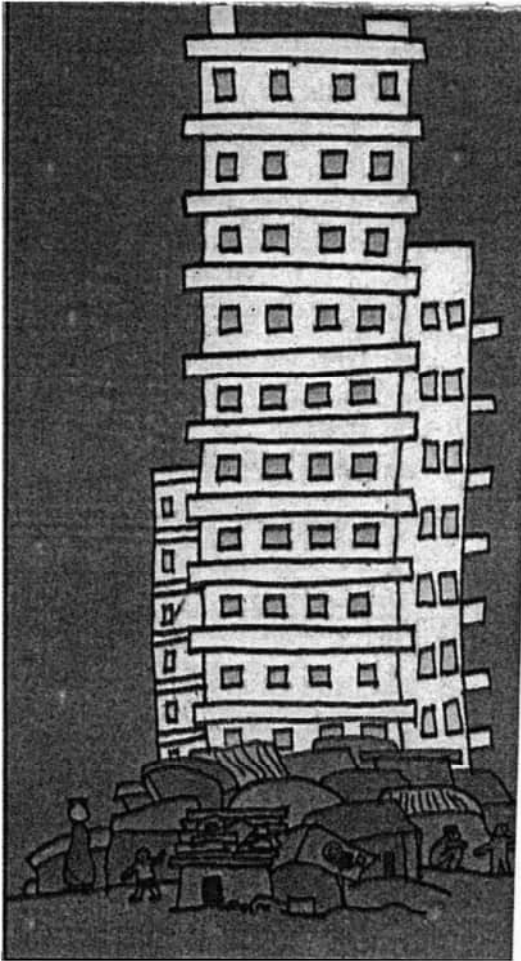

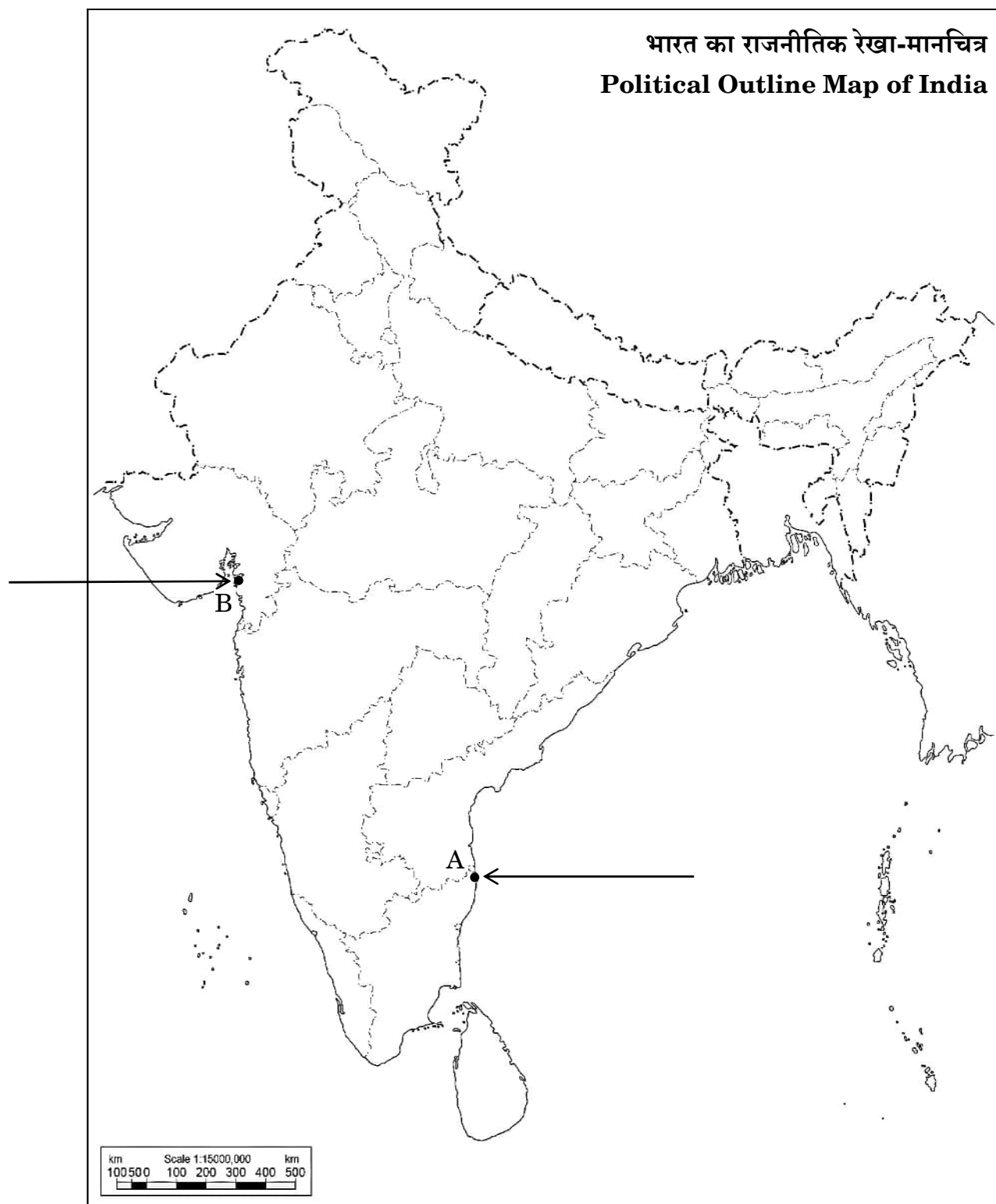
